PFHOA ANNUAL MEETING Held DEC 2, 2017

We want to thank all residents who attended the recent PFHOA Annual Meeting. It was great to see everyone there taking an active part in community affairs. Here's a recap of what went on:

- -Minutes from Annual Meeting of 2016 read and approved
- -Treasurer's Report presented
- -Everyone was asked to make sure to keep the Board up to date with current contact information, i.e. email address, telephone, etc.
- -The matter of repairing Pleasant Farm roads was addressed.
- -Report was provided on Hurricane damage and repairs from the previous year
- -Everyone was asked to review the PFHOA Covenants and suggest changes as appropriate. Covenants are found in the documents on the Pleasant Farm Website.
- -There was discussion about installing security cameras at the neighborhood entrance. The consensus agreed that the extra security was a good idea. Estimates have been

reviewed and cameras will be installed in the coming weeks.

- A vote on increasing the PFHOA Dues by 10% was deferred to the next Quarterly PFHOA meeting because notification letters didn't go out at least 30 days in advance of the vote. However, a 5% increase will take effect at the beginning of the year as provided for by the PFHOA By-Laws. If the additional 5% increase is approved at the Quarterly meeting, the increase will be retroactive to the beginning of the year.
- -In the coming weeks efforts will be made to install electricity at the front entrance to provide landscape up-lighting. The sprinkler system will be repaired and landscape enhancement will get underway.
- -A report was provided on the community properties that were undergoing foreclosure proceedings. Adjacent neighbors to these properties were asked to help maintain them until final disposition.
